Delivery (1-4 points)	Voice volume, posture, gestures, and eye contact, make the speaker(s) appear polished and confident. Members were well versed in their material, and included personal experience in their answers.		A small number of students answered the judges' questions. Students answered primarily factually and included a little personal experience in their answers.	A small number of students answered the judges' questions.
